



HERO10X ACCOUNT OPENING AGREEMENT

01 INTRODUCTION

These Terms and Conditions ("Agreement") govern the use of the Hero10x Account ("Account") offered by HFXLTD ("Company"). By purchasing and using a Hero10x Account, the client ("Client") agrees to comply with the terms set forth herein.

02 Definition of Hero10x Account

- 2.1 The Hero10x Account is a unique trading account where the balance is multiplied by a factor of 10 relative to the purchase price.
- 2.2 Unlike traditional trading accounts, Clients do not deposit funds but purchase a specific Hero10x Account type.
- 2.3 Account types and prices are as follows:

03 Account Rules and Stopout Level

- 3.1 The equity of the Hero10x Account must not be equal to or lower than 10% of the initial account balance at any time.
- 3.2 This equity level is static and does not change based on trading performance or withdrawal activity.
- 3.3 If the equity reaches or falls below 10% of the initial balance, the Account is deactivated, and no further trades or actions can be performed.

04 Withdrawal Policy

- 4.1 Profits can be withdrawn from the Hero10x Account to the Client's wallet at any time.
- 4.2 The initial purchase price of the Hero10x Account is non-refundable and cannot be withdrawn, as it is considered a purchase.
- 4.3 Only the profits generated through trading activities are eligible for withdrawal.

05 Trading Conditions

5.1 Swaps and Spreads

- Swaps are identical to other account types.
- Spreads are the same as for other trading accounts, except for "Raw Spread."

5.2 Leverage

The default Leverage for all 10x accounts are shown in the table below, and can be modified at any time at the brokers sole discretion:

5.3 Commission Per Asset Class

Commission rates for trading are as follows:

06 Account Deactivation and Reactivation

6.1 If the equity level falls to or below 10% of the initial balance, the Account is automatically deactivated.

6.2 Deactivated accounts cannot be reactivated or used for further trading.

8.2 HFXLTD adheres to strict Anti-Money Laundering (AML) policies and may request verification documents as necessary.

9.1 HFXLTD reserves the right to amend these Terms and Conditions at any time.

9.2 Clients will be notified of any changes through official communication channels.

9.3 Continued use of the Hero10x Account constitutes acceptance of the revised terms.

10 Governing Law and Jurisdiction

10.1 These Terms and Conditions shall be governed by and interpreted in accordance with the laws of [Jurisdiction].

10.2 Any disputes arising out of or in connection with this Agreement shall be submitted to the exclusive jurisdiction of the courts in [Jurisdiction].
